

Conversion to All Electric Heating and Cooling

Silicon Valley Power offers generous rebates for business customers to convert from natural gas heating to all-electric heating and cooling by installing a new energy-efficient heat pump. Rebates of **up to \$650** per ton are available. In addition, we offer **up to \$1,250** to help offset the cost of infrastructure improvements needed for installing the new equipment.

THINGS YOU SHOULD KNOW

Heat pump air conditioners are a proven technology and have greatly improved in performance and reliability over the last 20 years.

Santa Clara's mild climate is ideal for heat pumps without supplemental electric resistance heating. However, if supplemental or emergency heating is desired, its use should be limited during morning warm-up to reduce energy costs. This can be accomplished by installing a commercial-grade, programmable thermostat that locks out supplemental heating when switching from unoccupied to occupied temperature settings.



HEAT PUMP WATER HEATER REBATES

Whether you're replacing an electric resistance or natural gas water heater, we've got you covered. Silicon Valley Power offers generous rebates of \$1,000 per unit for replacing an electric resistance water heater or \$3,000 per unit when you replace a natural gas water heater.

THINGS YOU SHOULD KNOW

Heat pump water heaters use heat from the surrounding air to heat water and should be installed in a space with proper air circulation.

Before converting to a heat pump water heater, determine if the location of your current water heater will provide adequate airflow for a heat pump water heater. Silicon Valley Power energy engineers are available to help you determine if a heat pump water heater is right for you and select eligible equipment to meet your needs.





CUSTOM MEASURE REBATES

Silicon Valley Power offers rebates for replacing natural gas equipment with energy efficient electric equipment.

Rebates up to 65% of the project cost are available for installing equipment including:

- · heat recovery chillers
- · heat pump pool heaters
- heat pumps replacing large A/C units with gas heat or
- efficient electric equipment that replaces other gas equipment

To ensure a project meets all program eligibility requirements, we recommend customers consult with an energy engineer during the design stage of any project. All projects require pre-approval prior to installation.
